**MOTION TO SHORTEN TIME,
AND TO APPROVE FORM OF NOTICE**

The captioned debtors and debtors in possession (the “Debtors”), by and through their undersigned counsel, hereby move this Court for an Order approving the form of notice (the “Notice”) and shortening the time to object or respond to the attached “**Debtor Motion for an Order Approving Voting Procedures with Respect to Debtors’ and Official Committee of Unsecured Creditors’ Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code**” (the “Motion”). The Debtors seek, by the Motion, this Court’s approval of voting procedures and forms of ballots and related documents in connection with the Debtors’ proposed plan.

The Debtors seek an order from this Court requiring that objections, if any, to the Motion must be filed with the Court and served upon both undersigned counsel on or before September 17, 2001, at 4:00 p.m. Eastern Time.

Given the nature of the relief requested in the Motion, the Debtors respectfully

WHEREFORE, the Debtors respectfully request the entry of an Order approving the form and manner of Notice and providing that notice of the attached Stipulation shall be shortened as stated above.
